A STINGING DEFEAT

The Left was handed a stinging defeat last month and make no bones about it – **the Second Amendment was on the national ballot and we won – big time!** Californians can join the rest of the nation in a victory dance, because we will absolutely reap the benefits of the Trump win and crushing red wave.

It's always good to report the wins and we had some huge ones in the Golden State: First and foremost, California voters got it right and said NO MORE to rampant crime and passed Proposition 36 - which rolls back some of the most controversial and disastrous soft-on-crime policies on the books. It cannot be overstated just how big this is and what it says about California - the Left pushed us to the brink ten years ago with the disastrous Proposition 47, which was nothing more than a "get out of jail free" card for criminals and smash and grab mobs. No more! In fact, every single one of California's 58 counties voted to be tougher on crime and supported Prop 36.

Plus, voters in Los Angeles gave a swift boot to District Attorney George Gascon, who faced an intense and welcomed backlash against his pro-criminal-extremist policies. He was singlehandedly responsible for the sharp uptick in LA County crime, and the majority of Angelinos had had enough of Gason's progressive policies. Liberal Alameda County has apparently recalled their Leftist district attorney and even San Francisco got into the game and has ousted Mayor London Breed. The ground is usually the only thing that shifts in the San Francisco Bay area, but this time, there was a political shift as well.

GOC has been very vocal – particularly in the past few years – that our greatest victories have come at the federal level and that **these wins land square on the shores of California!** With control of the U.S. Senate, the confirmation of numerous federal judges who will support and defend the Second Amendment is all but assured – and this means our precedent-setting legal wins will increase, whether in the Golden State or elsewhere. GOC goes where we are needed, where we can have the most impact and sometimes this means out of state.

Barack Obama, Joe Biden and Kamala Harris have each generated a spike in gun sales – and even though we resoundingly defeated their anti-gun policies, this is **NOT the time for GOC to slow down. We must put the peddle to the metal** – and move our pro-2A message forward.

We believe a message has been delivered loud and clear, from one end of the country to the other: hands off the Second Amendment and no more spineless, zero accountability free rides for criminals - especially here in California.

Had Kamala Harris won the presidency, she would have continued to weaponize the power of government against our Second Amendment rights. **THANK YOU FOR STOPPING HER!** Now we must be prepared for what's sure to come: after a short period of mourning, and blaming everybody but themselves, the Left will regroup and prepare for their next battle against us. And we will be ready.

THE RESULTS ARE IN

We have every reason to celebrate the results of the national elections. Pro-gunners have won the White House, the U.S. Senate, and the House of Representatives. Make no mistake about it: we will be asking much of these federal leaders when it comes to overturning nationwide gun control. Period.

But what about California? 40% of California voters supported former President Trump this go-around, which is roughly 8% more than in 2020. In doing so, 10 counties that formerly voted blue flipped and voted red this time. This is very significant and has a lot of Leftists wondering what the heck happened (a common occurrence since November 5).

GOC wants to be perfectly clear: even though gun control was not specifically on the ballot, crime control was, nationally and in the Golden State. Newsom Strikes Back

Governor Newsom is so worried about the obvious shift in California's voting that he decided to call for a Special Session of the Legislature. Why? To fight the incoming Trump Administration and the devastation he thinks will befall the state.

The session will focus on "bolstering California legal resources to protect California values, civil rights (**read that gun control**), reproductive freedom, climate action, and immigrant families."

California values? The dude has got to be kidding – especially with him at the helm!

The California Globe put a good spotlight on Newsom's vision: "Look around you – you see drug addicted vagrants living in parks, on city streets, along rivers and bike trails. You see brazen retail theft when you shop at Target, Macy's, your neighborhood pharmacy, and convenience stores...

Do you feel safe in your neighborhood park? Do you feel safe in the parking lot at your grocery store? Is it safe for your child to walk to school? Can you afford the home or apartment you are renting? How about your PG&E, SCE or SDGE electric and gas bills? How about filling your car with gas – too expensive for a full tank? CLOSING OUT 2024: THE LEGISLATURE AND THE COURTS

The 2023/2024 Legislative Session officially wrapped up on September 30, the Constitutional deadline for Governor Gavin Newsom to sign bills which had landed on his desk, courtesy of having been passed by both the Assembly and Senate.

GOC began the session tracking over 45 bills. The worst of the worst (annual registration and insurance reports on guns in the home) were amended to be non-substantive and the remainder were significantly watered down.

AB 2917 | Signed by Governor Gun Violence Restraining Orders| Zbur (D)

Expands highly subjective criteria in issuance of GRVO; threats of violence.

AB 3064 | Signed by Governor Firearm Safety Devices | Maienschein (D)

Mandates DOJ certify/issue fee for firearm safety devices. If device is de-certified, owner could be penalized for non-compliance.

AB 3067 | FAILED

This bill by Mike Gipson (D) initially mandated insurance companies ask about guns in the home. All firearm-related text was amended out of the bill. **This was a big win.**

SB 53 | Signed by Governor Firearm Storage | Portantino (D)

This is a duplicative bill mandating firearm storage; it clearly violates federal case law. Further, it was significantly weakened from it's original, introduced version.

SB 1038 | FAILED Firearm Theft | Blakespear (D)

Limits time to 48 hours for persons to report the theft of a firearm.

SB 1160 | FAILED

This bill by Sen. Portantino initially established annual registration of firearms in CA; due to heavy opposition led by GOC, SB 1160 was amended to be an irrelevant measure and died on the Suspense File. **THIS IS THE MOST SIGNIFI-CANT WIN OF THE YEAR.**

SB 1253 | – FAILED Firearm Safety Certificates | Gonzalez (D)

This bill was significantly amended to only require those moving into CA to have a valid firearm safety certificate within 60 days.

THE COURTS

The following is a brief snap-shot of our current legal activities across the nation as the **AMICUS BRIEF WRANGLER:**

Federal Firearms Licensees of Illinois et al v. Pritzker et al

<**BREAKING>>** Federal District Court ruled Illinois "Assault Weapons" and "Large Capacity Magazine" bans unconstitutional.

Antonyuk v Negrelli "ASSAULT WEAPON" BAN | New York Waiting: SCOTUS is in the process of de-

ciding whether to hear this case.

U.S. v Rahimi THIS IS A KEY LEGAL CHALLENGE TO "RED FLAG" LAWS

SCOTUS reaffirmed the Bruen decision.

CRPA v LA Sheriff's Dept. CHALLENGES EXPENSE, TIMELINESS AND PROCESS ON CCWS

We had a *partial* victory in the District Court; the case is being continued so stay tuned.

May v Bonta CHALLENGES SB 2 "SENSITIVE PLAC-ES" LAW FOR CCWS

We won in the District Court, but California has appealed the decision to the 9th Circuit. We have appealed for an en banc (full court) hearing.

Baird v Bonta CHALLENGES A BAN ON "OPEN CAR-RY" IN CALIFORNIA

A 3 judge panel of the 9th Circuit overruled the district judge; currently waiting for a potential appeal by the State.

Rupp v Becerra/Bonta CHALLENGES CALIFORNIA'S "ASSAULT WEAPONS" LAWS

The Central District Court ruled in favor of California. We have appealed to the 9th Circuit, where it is being held pending a decision in the Duncan case.

Duncan v Becerra/Bonta CALIFORNIA'S STANDARD CAPACITY MAGAZINES

SCOTUS sent this case back to the 9th Circuit; we are awaiting a decision.

Miller v Becerra/Bonta "ASSAULT WEAPON" BAN

The 9th Circuit is holding the case pending the result of Duncan v Bonta.

Rhode v Becerra/Bonta CA'S AMMO SALES LAWS & REGULATIONS

The 9th Circuit is holding the case pending the result of Duncan v Bonta.
