Bill Summary: This bill modifies existing law regarding the sale and use of "unsafe handguns," which are firearms that do not meet specific safety standards and are generally prohibited from being manufactured or sold in California. The primary change is to allow sworn members of county probation departments to use unsafe handguns as service weapons, provided they complete the firearm portion of a training course prescribed by the Commission on Peace Officer Standards and Training (POST) and qualify with the weapon at least every three months, a more frequent requirement than previously applied to some other law enforcement personnel.

GOC Commentary: Although this is considered a "carve out" for a specified group, we support the bill in concept. However, GOC believes all lawful, responsible Californians should have the same access to firearms as those in law enforcement.

Bill Summary: This bill expands access to firearm tracing data for academic and policy research purposes, allowing any town, city, or county, state government agency, California community college, California State University, or the University of California to request this information from the Department of Justice.

GOC Commentary: GOC has never minded research; what we don't like is research with a bias and a political axe to grind. The bill expands the distribution of firearm tracing data maintained by the California Department of Justice. While presented as a transparency and research measure, AB 1743 significantly broadens access to sensitive firearm trace information and shifts the law from allowing discretionary sharing of data to a wide range of government entities. Distributing such broad dealer-level trace data creates the risk that lawful firearm retailers could be singled out or publicly criticized despite having committed no wrongdoing. Firearm trace data alone does not establish dealer misconduct and can easily be misinterpreted.

Bill Summary: This bill makes several changes to laws concerning protective orders, primarily focusing on firearms and ammunition. It explicitly requires individuals subject to certain protective orders, including civil harassment, domestic violence, elder abuse, workplace violence, and postsecondary school restraining orders, to relinquish not only any firearms but also any ammunition in their possession or control.

GOC Commentary: GOC's primary concern regarding "red flag" laws pertains to the absolute necessity of an individual's right to due process - assurances that infringements of the 1st, 2nd and 4th Amendments are paramount. Whether it's the First or Second Amendment, the underlying due process arguments remain the same. It's one thing — an authoritarian thing, for sure — to argue that some of our rights are so dangerous that we should now ignore fundamental Constitutional protections.

Bill Summary:	Existing law requires DOJ to conduct inspections of firearms dealers at least every 3 years to ensure compliance. This bill would require the department to remove from the list a person who fails to comply with the requirements to be on the list and authorize the department to remove a person from the list who fails to remedy specified violations discovered as a result of the above-described inspections. The bill would subject a person removed from the list for these 2 reasons to a fine and make that person ineligible to be placed on the list for a period of 2 years. The bill would require the department to conduct a yearly inspection of the 10 firearm dealer locations with the highest percentage of total sales of firearms that were recovered by law enforcement and found to be illegally possessed, used in a crime, or suspected to have been used in a crime.
GOC Commentary:	Trace data is not an effective means of addressing crime; this bill puts dealers at risk for penalties for crimes that occur after they have sold a firearm and it is out of their possession.

Bill Summary:	This bill amends existing California law regarding firearms and concealed carry licenses, specifically changing the duration for which these licenses are valid. Currently, a new concealed carry license is valid for up to two years, and a renewal license is also valid for up to two years. This bill proposes to extend the validity of a new license to three years from the date it is issued, and a renewal license to six years from the date of renewal.
GOC Commentary:	This is a positive and necessary change to the CCW system.

Bill Summary:	Under current law, anyone who personally uses a firearm in the commission of a specified felony offense shall be punished by an additional and consecutive term of imprisonment in state prison. It also prohibits these firearm enhancements to the lawful use or discharge of a firearm by a peace officer; this bill would place the burden of proving by a preponderance of the evidence on the prosecution that the firearm enhancements apply to a peace officer.
GOC Commentary:	This is a positive policy move.

Bill Summary:	Current law requires a person, who claims title to a firearm that is in the custody of a court or law enforcement agency and wishes to have it returned, to make an application to the Department of Justice as to whether the applicant is eligible to possess a firearm. A law enforcement agency or court that has taken custody of a firearm is prohibited from returning the firearm to an individual unless specified requirements are met. This bill would authorize a law enforcement agency to create a voluntary firearm storage program that allows a person to voluntarily transfer custody of their firearm to the local law enforcement agency for temporary safekeeping purposes.

Bill Summary:	<p>AB 2047 would mandate California's Department of Justice to investigate, certify, and regulate firearm blueprint detection algorithms and require printer manufacturers to install state-approved blocking technology. In addition, AB 2047 would also ban printers from sale in California that are not equipped with certified software.</p> <p>Placing sweeping technological restrictions such as the distribution of code on lawful businesses and consumers clearly infringes on First Amendment protections for expressive speech. Such requirements represent an unprecedented intrusion into personal manufacturing and innovation – especially given that 3D printing is widely used for legitimate purposes by legitimate businesses throughout the country.</p>
GOC Commentary:	<p>3D printing is not an inexpensive endeavor; it's a high cost, limited production technology and the requirements of AB 2047 burden innovation, restricts consumer access, and expands enforcement authority, all while criminals remain free to ignore compliance schemes. What's more, it is currently illegal under both federal and California law to manufacture, import, sell, transfer, or possess an undetectable firearm. A more effective course of action might be to simply add enhancements to those crimes committed with 3D printed guns. It would be far more direct and get to the issue of criminal misuse of firearms.</p>

GOC Commentary:	<p>GOC is not sure this bill is necessary, we are in discussions with Assemblyman Alanis on his proposal.</p>

Existing law requires the juvenile court to notify the Department of Justice of persons subject to these provisions, as specified.</p> <p>This bill would require the juvenile court to notify the department if the court grants a dismissal of a juvenile petition for an offense that subjected the juvenile to the above-described firearm prohibition.</p>

Bill Summary:	<p>AB 2378 would create the Office of Community Violence Intervention within the Board of State and Community Corrections, and would require the office to improve public health and safety by supporting effective community gun violence reduction initiatives in communities that are disproportionately impacted by community gun violence. "Community gun violence" is defined as "intentional acts of interpersonal violence involving a firearm, generally committed in public areas by individuals who are not intimately related to the victim, and which result in physical injury, emotional harm, or death."</p>
GOC Commentary:	<p>Gun Owners of California is not opposed to "gun violence reduction initiatives" per se – there is reasonable concern however, given the complexities and controversies of firearm use and misuse. There are wide differences of opinion, observations and analysis by noted academic scholars even when researching the same set of data, not to mention the persistent hostility toward lawful Californians who choose to exercise their Second Amendment right to own and use firearms. What data is proposed to be used for such initiatives, how it was gathered – what is included and what may be excluded, who is doing the research, and whether there would be a balanced approach are reasonable concerns given the high emotion that the subject of gun violence produces – on both sides of this important issue. At this juncture, however, the fiscal price tag is reason enough for this bill to be opposed.</p>

The bill would prohibit a party's background, training, and professional fighting skills from being taken into account when determining whether a party has taken reasonable defensive action.</p>

GOC Commentary:	<p>This resolution is non-binding, unenforceable and is nothing but a cheap shot at President Trump. It is a waste of taxpayer's money to have had it introduced, voted on and likely signed by Governor Newsom. It will do absolutely nothing to put a dent in the damage caused by the criminal misuse of firearms.</p>

Bill Summary:	<p>This bill would require an applicant for a firearm safety certificate - or in other words, anyone who purchases a firearm to complete a training course no less than 4 hours in length that, among other things, includes instruction on firearm safety and handling and live-fire shooting exercises on a firing range.</p>
GOC Commentary:	<p>SB 948 would require any individual seeking to purchase a firearm—by way of obtaining a Firearm Safety Certificate—to complete a training course of no less than 4 hours that includes live-fire shooting exercises.</p> <p>No other enumerated constitutional right—whether speech, religion, voting, or due process—requires citizens to complete state-mandated training before it may be exercised. Yet this is precisely what SB 948 would impose. The bill transforms a guaranteed right into a government-mandated permit-to-purchase scheme for a product the state has already deemed lawful to own. This legislation would impact individuals across all demographics and would disproportionately burden first-time firearm purchasers.</p>

Bill Summary:	This bill requires the California Fish and Game Commission to establish a program by January 1, 2028, to increase fishing and hunting opportunities for resident youth with life-threatening illnesses, which are defined as conditions that could lead to death within five years or less as certified by a physician. The program will focus on activities such as big game, wild pig, upland game bird, and migratory game bird hunting, as well as fishing.

GOC Commentary:	This is yet another attempt to expand the prohibition on firearm ownership; by banning possession for a period of 10 years for simply possessing a gun without a serial number is excessive and will do nothing to address the criminal misuse of firearms.
